A determined advocate for social justice, Sissy realized very few organizations addressed the needs of the Southeast Asian community and created a new program—SEACA, empowering the Southeast Asian community through leadership development, education, advocacy and organizing. Through SEACA's innovative organizing with youth, SEACA uses land use policy reform to take on the City of Los Angeles and a new wave of gentrification slated for Chinatown that was proceeding with no meaningful input from residents. SEACA was the organizer connecting the dots, bringing in land use experts and youth members, and successfully moving policy through City Hall that will eventually generate \$200 million of affordable housing for their local community.
